Compute the Total Tax without Exemptions using the Total Consolidated Rate →		TO CALCULATE FULL TAXES FOR A GIVEN PROPERTY, DIVIDE THE ASSESSMENT BY 1,000 AND MULTIPLY THE RESULT BY THE CONSOLIDATED RATE. EXAMPLE: A property assessed at 450,000 in the Village of Briarcliff Manor with Ossining schools : 450,000 / 1000 X \$29.31 = \$13,189.16 * For Unincorporated Town Sewer Districts you must add a \$75 sewer unit charge to the Total Tax Due.
