In continuing business, Chief Franzoso spoke about EMT Legislation coming from Albany that requires Counties to come up with EMS plans. Counties are waiting for guidelines on how to accomplish this. Village of Ossining Manager D'Attore noted that OVAC will serve as a great resource to Counties as they formulate their EMS plans.
