NOTICE: You are required to insulate hot water pipes if any of these conditions are met:

R403.5.3 Hot Water Pipe Insulation (Prescriptive).

Insulation for hot water piping with a thermal resistance, R-value, of not less than R-3 shall be applied to the following:

1. Piping 3/4 inch (19.1 mm) and larger in nominal diameter.
2. Piping serving more than one dwelling unit.
3. Piping located outside the conditioned space.
4. Piping from the water heater to a distribution manifold.
5. Piping located under a floor slab.
6. Buried piping.
7. Supply and return piping in recirculation systems other than demand recirculation systems.

We cannot pass or approve any installations that do not conform to this code requirement!
